

## Single User License Agreement

**This Single User License Agreement is date as specified on the relevant invoice.**

Under this License Agreement between Select Knowledge Limited whose registered address is at Enterprise House, 5 Roundwood Lane, Harpenden, Hertfordshire, AL5 3BW ("SK"), and The Licensee, whose address is specified on the relevant invoice, a licence is granted to enable The Licensee, to produce copies of the products listed in the Schedule 1 ("the Products") for internal use by and on behalf of The Licensee only.

This Agreement continues from the date specified on the relevant invoice for a period of one year (the Term). SK grants to The Licensee a non-exclusive license to reproduce the Products during the Term in hard copy print form only and thereafter to use such copies for its own internal purposes. The Licensee shall not sell give or transmit the Products or copies of the Products or any licenses in respect of the Products to any third party.

**The Licensee shall not:**

Assign, sub-license any of the Rights except with the prior written consent of the Licensor.

Allow the Products to be used by its employers, employees or former employees or candidate, students, clients for any purpose other than in connection with the Licensee's sole training and education.

THE LICENSEE acknowledges that the Select Knowledge name and logo plus any other name, brand or logo of SK which is included on the Products (together the "SK Trademarks") and all rights and goodwill pertaining thereto are the property of SK, and understands and acknowledges that SK owns all right, title and interest in and to the SK Trademarks. No rights to the SK Trademarks or any products, services or goods of SK other than the Products are granted under this Agreement. The rights and license granted to Licensee are non-transferable and are limited solely to the Products.

Ownership of copyright and all other intellectual property rights in the Products shall be vested solely in SK. THE LICENSEE shall faithfully reproduce on each copy of the Products produced by it hereunder any copyright or other notices which SK may have included on the Products.

Subject to the rights granted by this Agreement THE LICENSEE shall not alter, modify or adapt the Products.

THE LICENSEE shall be solely responsible for all and any costs involved in copying the Products in accordance with this Agreement.

THE LICENSEE agrees to pay SK a fixed fee as specified in the relevant invoice for the Products in consideration of the license granted by this Agreement. THE LICENSEE shall pay all fees owing under this Agreement before the Products is supplied.

THE LICENSEE shall remit all payments in Pounds Sterling by credit card, cheque or bank transfer to SK's account, which shall be specified on the relevant invoice or website.

On expiration of this Agreement, THE LICENSEE agrees to cease all use of the Products in print and electronic form and shall destroy any electronic and printed copies of the Products.
